During the reporting period the Committee held four meeting and discussed issues regarding the implementation of the N Headquarters Agreementas well as the Convention on the Privileges and Immunities of the United Natibassies concerning entry visas and travel restrictions were of particular concerduring these discussions.

The Committeewill continue its efforts and will remain seized of this sues that re on its agenda in order resolve them a spirit of compromise and in full regard the interests of the Organization and the integrity of the Headquarters Agreement.

The Report provides a comprehensive description of the issues raised in the Corttmittee presents the differing views expressed by the concerned Missions and by the host country on these issues and on how each party considers that y should be resolved to the Recommendations and Conclusion shich areset out in Chapter IV of the Report Committee, *inter alia*, reiterates its expectation that the host country will ensure the issuance of entry visas to all representatives of Member States and members of the Secretariat in line with the Headquarters Agreement. Furthermoir eaddresses the treatment of diplomats transiting to and from the UN Headquarters diatriatell as the tightening of travel restrictions that are applied to a certain Mission between that bringing issues to the attein of the host country mayin some cases help to have them expeditiously resolved and notes the discussions that have been formalised since 2019 between the United Nations Legal Counsel and the competent authorities of the host country regarding unresolved issues depreted as the outcome of these discussions.

As in the previous yeawe have witnessed intense discussions on several items of great importance to the affected Member Stateselated to the implementation of the Headquarters Agreement in particular with respect tentry visas and travel restrictions The Committee has ontinued to struggle with the differing views as to whether progress has been made by the host country he context of the recommendations and conclusions that the Committee adopted last y cand which were edorsed by the General Assembly. Of particular importance was the question of what was the way forw affect the insues raised in the report of the Committee remained unresolved following a reasonable and finite period of time". In that regard the Committee once again, reiterates its request to the Secretary-General to now give the most serious consideration and take any appropriate steps under section 21 of the Headquarters Agreement and intensify efforts to expedite resolution of the issues". I believe that the recommendations and conclusions of this year's Report on which the members have reached consetheousghextensivebut constructive negotiations accurately reflect this situation
