2023 is the 75th anniversary of the UDHR. Its achievement bringing focus and expectation for rights should be celebrated, but now, at the Summit of the Future, as a matter global governance through a renewed social contract,

It was this linkage between rights and courts for which Rene Cassin was awarded the Nobel Peace Prize for his work both as a drafter of the UDHR and as the President/Judge of the European Court of Human Rights.

There is much talk about how the Summit of the Future will address the disparities between the global north and the global south. One way to correct this imbalance is to bring the Regional Court systems, the African Court of Human and People's rights
