. This allows for issuance of visa authorization letters, which enable participants to board flights, and for smooth entry into the country.

- Invitation letter from the Host/UN-OHRLLS (this is required for both individuals and organisations)

a) Payments

- P500 Single Entry – for a period up to 3 months,
- P1000 multiple Entry- for a period up to 3 months,
- P1500 multiple Entry – for a period of 6 months to 1 year,
- Gratis- for Diplomatic/service /official passport holders/UNLP.

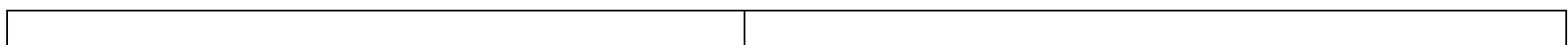
